

## **WARRANTY POLICIES**

### **LIMITED TWO (2) YEAR WARRANTY FOR DEVILBISS DV1 COATING EQUIPMENT PRODUCTS**

#### **WHAT IS COVERED?**

Carlisle Fluid Technologies ("CFT") warrants to the original commercial purchaser ("Commercial Purchaser") that the DeVilbiss DV1 product manufactured by CFT, under normal use and service, will be free of defects in workmanship and material for two (2) years from date of purchase. This warranty is extended to, and can only be enforced by, the Commercial Purchaser. This warranty is not transferable and is expressly conditioned upon submission of proof of date of purchase of product.

#### **WHAT IS EXCLUDED?**

This warranty shall not apply to defects or damages arising from any of the following:

- accidents, abuse, misuse, misapplication or negligence;
- improper or unauthorized repair or alterations;
- ordinary wear and tear.

This warranty does not cover:

- Products not manufactured by CFT;
- Costs with respect to the removal, replacement, or repair of products (other than by CFT), without prior written authorization from CFT;
- Repair costs of products determined by CFT not to be defective or not presented for warranty service within the warranty period.

#### **WHAT WILL CFT DO?**

CFT will, at its option, free of charge, repair or replace, provide replacement parts or issue a credit in the amount of the purchase price minus a deduction for Commercial Purchaser's usage of any DeVilbiss DV1 product covered by this warranty that is found to be defective in material and workmanship during the two (2) year warranty period. If the original product is no longer available at the time of repair or replacement under the terms of this warranty, CFT has the right to substitute another CFT product or replacement parts of equal or greater value than the original product. No repair or replacement under the warranty shall extend the warranty period.

#### **WHAT YOU NEED TO DO:**

In the event that the DeVilbiss DV1 product manufactured by CFT does not perform as you expected, please verify that the product has been accurately selected for the chosen job and that the product is properly installed, maintained and operated.

To make a claim under this warranty, present the product covered by this warranty, with proof of date of purchase, to your DeVilbiss Authorized Sales Outlet through which the original product was purchased, or contact the DeVilbiss distributor nearest to you (consult your local directory under "Automobile Body Shop Equipment and Suppliers" or [www.autorefinishdevilbiss.com](http://www.autorefinishdevilbiss.com)). If the DeVilbiss Authorized Sales Outlet/Distributor is unable to resolve your warranty claim, you will be provided with instructions on where to send the product for warranty determination and service. All shipping and insurance charges will be paid by the Commercial Purchaser. CFT is not responsible for products sent without prior authorization from CFT.

#### **GENERAL**

THE FOREGOING SHALL CONSTITUTE THE EXCLUSIVE REMEDY OF THE COMMERCIAL PURCHASER SEEKING TO ENFORCE THE WARRANTY AND THE EXCLUSIVE LIABILITY OF CFT. THE ABOVE WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER EXPRESS AND IMPLIED WARRANTIES, WHETHER ORAL OR WRITTEN.

CFT SHALL NOT, UNDER ANY CIRCUMSTANCES OR UNDER ANY LEGAL THEORY, BE LIABLE TO THE COMMERCIAL PURCHASER OR ANY OTHER PERSON FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY NATURE, INCLUDING WITHOUT LIMITATION DAMAGES TO, OR LOSS OF USE OF, PROPERTY, DAMAGES FOR LOSS OF PROFITS OR REVENUES OR ANY OTHER DAMAGES ARISING FROM THE COMMERCIAL PURCHASER'S PURCHASE OR USE. CFT'S LIABILITY SHALL IN NO EVENT EXCEED THE PURCHASE PRICE OF THE PRODUCT.

All decisions of CFT with regard to this policy shall be final. No agent, dealer, employee or representative of CFT nor any distributor, retailer, installer or other person is authorized to modify the warranty in any respect. The invalidity of all or a part of any of the provisions of the Limited Warranty shall not affect or invalidate any other provision of the Limited Warranty.
